Notes to the Financial Statements For the Year Ended 30 June 2023

The financial statements cover Barbara Jefferis Literary Fund and have been prepared in accordance with the trust deed to meet the needs of the trustee.

1 Basis of Preparation

The Trust is non-reporting since there are unlikely to be any users who would rely on general purpose financial statements.

The special purpose financial statements have been prepared in accordance with the significant accounting policies described below and do not comply with any Australian Accounting Standards unless otherwise stated.

These financial statements have been prepared on an accrual basis and are based on historical costs unless otherwise stated in the notes.

2 Summary of Significant Accounting Policies

(a) Cash and cash equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

(b) Financial instruments

Financial assets

The Trust's financial assets comprise shares and notes in listed companies and unlisted managed funds measured at market value.

Unrealised gains or losses in the market value of investments are recognised in the income statement.

(c) Revenue and other income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the Trust and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.



Report on the Audit of the Financial Report

Opinion

We have audited the accompanying financial report, being a special purpose financial report of Barbara Jefferis Literary Fund (the Trust), which comprises the balance sheet as at 30 June 2023, the income statement for the year then ended, notes to the financial statements, including a summary of significant accounting policies, and the Trustees' Declaration.

In our opinion, the accompanying financial statements of the Trust for the year ended 30 June 2023 are prepared, in all material respects, in accordance with Note 1 to the financial statements.

Basis for Opinion

We conducted our audit in accordance with Australian Auditing Standards. Auditor's Responsibilities for the Audit of the Financial Statements
